IRS REPORTING

Only the official IRS landscape format can be submitted when reporting to the IRS.

EMPLOYER FILE COPY AND REPORTING

Employers must file with the IRS using the landscape format only. They are also required to keep a copy on file and provide a copy to the recipient for their records.

RECIPIENT REPORTING

Employers and Insurance Carriers may provide the employee/recipient the approved portrait format. These are available in pre-printed or blank form version designed to accommodate envelope 77771. We recommend you review software compatibility.

IRS LANDSCAPE FORMAT IS NOW TWO PAGES

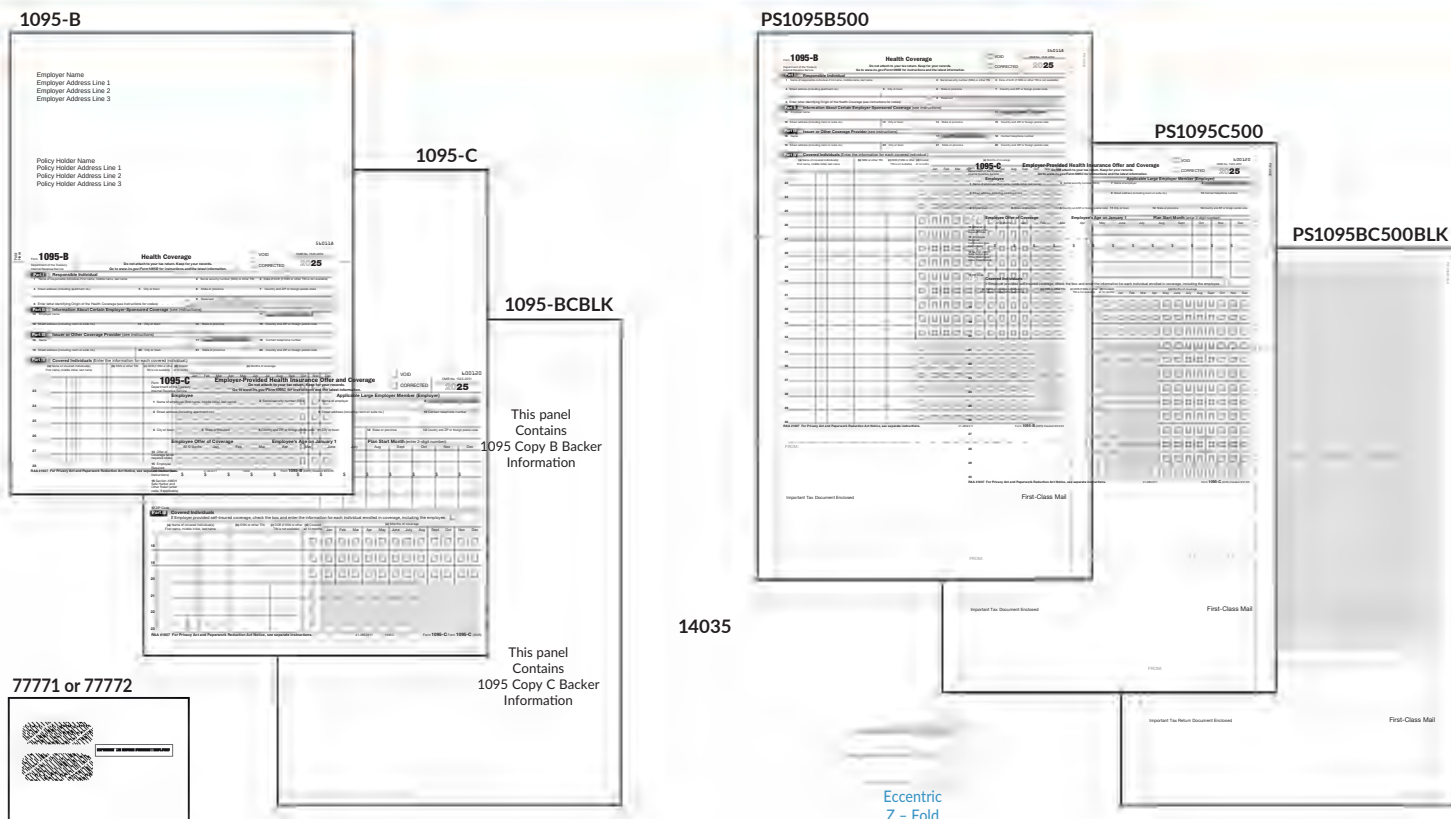
